The Clinic will be held at Odessa's Schlemeyer Airport---ODO. Plan to arrive Wednesday for a **ground school to be held Wednesday evening starting at 6:30 pm instead of Thursday** morning. This will give us more flying time for training. New formation candidates or lead upgrades must attend the appropriate ground school to be eligible for their respective cards.

**Note --You don't have to be a traron or CAF member to attend this clinic so bring your non CAF buddies to join in the fun. The only requirement to attend if you are not flying a CAF owned aircraft is to have the proper insurance rider on your personally owned aircraft. The following statements must be added to your policy by your insurance company and this is usually a free service but plan ahead since it usually takes a few days to get done.**

(a) The CAF must be named as an "additional insured" on the aircraft owner's insurance, with coverage of \$1,000,000 Combined Single Limit Bodily Injury and Property Damage, subject to a sub limit of \$100,000 per passenger. The "additional insured" should read as follows:

**"The Commemorative Air Force, Inc. (and the various Wings, Squadrons, and Divisions thereof) The American Airpower Heritage Foundation, Inc., The American Airpower Heritage Flying Museum, inc., The American Airpower Heritage Museum, Inc, Steve Brown, President, PO Box 62000, Midland, TX 79711-2000.**

(b) A waiver of subrogation is provided in favor of the CAF.

(c) A written confirmation is provided by the aircraft owner's insurance company stating that the policy covers the intended use of the aircraft for the intended event.
