It is time to renew your annual TRARON membership again. Dues for the calendar year 2009 are \$25.00, and can be sent to TRARON at the address below. Sending them directly to Skipper will only delay the process, so please use the address below. Please remember that if you are delinquent for any dues from previous years, you must include payment for those years too in order to be current with your 2009 dues. The dues for previous years are also \$25.00 per year. For those members who have already paid their 2009 dues, please note that you will also need to be current with the CAF and have a current proficiency report on file in order to receive your new 2009 FAST Card. If your CAF membership has lapsed and been renewed recently, or you have just recently joined the CAF, please send or fax in a copy of your new CAF membership for us to have on file. We will be sending out new cards, not just the stickers, as the 2008 cards expire on December 31, 2008.

Those members who did not submit a valid proficiency report in 2008 will need to do so in 2009 before we can issue a new 2009 FAST card. Proficiency reports dated in 2007 will expire as of December 31, 2008, and any proficiency reports that are submitted in 2008 will count through December 31, 2009. Those submitted in 2007 will be valid through December 31, 2008. Please note that these reports must be filled out correctly and have the proper signatures if they are to count. **You cannot sign off for yourself!** If you need the proficiency report to count for yourself, you must have a second signature from another check pilot or lead in that flight, otherwise, the report will only count for the other members listed on the report. If you send us proficiency report having flown with a signatory other than TRARON, please provide a copy of the Check Pilot's card showing his level of authority with that signatory. The proficiency reports can be mailed, faxed or e-mailed to the below fax number and addresses.

We have enclosed a member update sheet with this letter. If any of your contact information has changed, or changes at some point in the year, please complete it and return to us by fax, mail or e-mail. This will help us a great deal, as we have had several returned e-mails and letters.

As a reminder, members should check the TRARON website often at [www.traron.org](http://www.traron.org). The website has the latest news and information, including future clinic dates. We have the dates of the next clinic on there, which will be held on January 16-18, 2009 in Riverside, CA for those who are interested.
